

**STANFORD TOWNSHIP  
BOARD MINUTES  
JANUARY 3, 2022**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:01 pm by Chairman Wayne Anderson.
2. **Roll Call:** Present were Chairman Wayne Anderson, Supervisor Scott Johnson, Treasurer Brenda Springer, Maintenance Kevin Springer and Clerk Barb Vogtlin. Supervisor Loren Daudt was excused.
3. **Adopt Agenda:** Motion by Scott to adopt the January 3, 2022 Township Agenda. Wayne seconded and approved the motion.
4. **Approve Minutes:** Motion by Scott to approve the December 6, 2021 Township Minutes. Wayne seconded and approved the motion.
5. **Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of December 1, 2021 \$109,767.59; Receipts \$199,846.45; Interest \$7.12; Disbursements \$45,626.44; ending balance as of December 31, 2021 \$263,994.72. Flagship Bank Savings Account \$18,499.82; Interest \$0.47; ending balance \$18,500.29; \$150,000.00 in CD's. Motion by Scott to approve the Treasurer's Report. Wayne seconded and approved the motion.
6. **County Commissioner's Report:** County Commissioner Greg Anderson stated that tomorrow is their Board Meeting. At their annual meeting they will be electing new chair, vice chair. Regular Board meetings will be the 1<sup>st</sup> and 3<sup>rd</sup> Tuesday of the month and work sessions will be the 2<sup>nd</sup> and 4<sup>th</sup> Tuesdays. The Final Budget was decreased a percent so as of right now it is 6.5% increase. He stated they will now be hiring one person to supervise unkept properties. He stated the County Engineer retired, Tony Henning left, the Hwy Department will have a big change this year. Wayne asked about the Auditor position. Greg stated it is appointed in a 4-1 vote, but the Recorder vote failed 3-2.
7. **Meeting Open to Public:** Dave Moritz was present and said the water line is now in, to his property on Feldspar Street.
8. **Dates of Board of Audit and Budget:** The Board of Audit and Budget meeting will be held March 1, 2022 at 5:00 pm.
