

**STANFORD TOWNSHIP
BOARD MINUTES
FEBRUARY 7, 2022**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:05 by Supervisor Loren Daudt.
2. **Roll Call:** Present were Supervisor's Loren Daudt and Scott Johnson, Treasurer Brenda Springer, Maintenance Supervisor Kevin Springer and Clerk Barb Vogtlin.
