

**STANFORD TOWNSHIP  
BOARD MINUTES  
JUNE 6, 2022**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:00 pm by Chairman Loren Daudt.
2. **Roll Call:** Present were Chairman Loren Daudt, Supervisor's Wayne Anderson and Scott Johnson, Deputy Treasurer Wendy Daudt, and Clerk Barb Vogtlin. Maintenance Supervisor Kevin Springer was excused.
3. **Adopt Agenda:** Motion by Wayne second Scott to adopt the June, 6, 2022 Township Agenda. Loren approved the motion.
4. **Approve Minutes:** Motion by Wayne second Scott to approve the May 2, 2022 Township Minutes. Loren approved the motion.
5. **Treasurer's Report:** Wendy read the Treasurer's Report as follows: Balance as of May 1, 2022 \$241,183.99; Receipts \$3,983.80; Interest \$8.15; Disbursements \$64,055.39; ending balance as of May 31, 2022 \$181,120.55. Flagship Bank Savings Account \$18,502.84; Interest \$1.53; ending balance \$18,504.37; \$150,000.00 in CD's. Motion by Scott second Wayne to approve the Treasurer's report. Loren approved the motion.
6. **Commissioner's Report:** None.
7. **Meeting Open to Public:** Don Hanson had two Final Plats. Langer Property – Final Plat – Splitting lot into 2 parcels. Grams Legacy -Final Plat, motion by Wayne second Scott to approve both Finals Plats for Langer Property and Grams Legacy. Loren approved the motion. Motion by Wayne second Scott to approve the Chairman and the Clerk to sign the Mylars once they are ready. Loren approved the motion.
