- **3. Adopt Agenda:** Motion by Scott second Wayne to adopt the August 4, 2025 Township Agenda. Loren approved the motion.
- **4. Approve Minutes:** Motion by Wayne second Scott to approve the July 7, 2025 Township Minutes. Loren approved the motion.
- 5. Treasurer's Report: Wendy read the Treasurer's Report as follows: Balance as of July 1, 2025 \$289,226.12; Receipts \$323,981.53; Void Check Sharal Hagstrom Check #10098 \$2,000.00; Interest \$784.04; Disbursements \$48,850.53; ending balance as of July 31, 2025 \$567,141.16. - 6. Commissioner's Report: County Commissioner Todd Christianson was present and said they will be starting the round about on County Road 5 and Hwy 47, at the end of this month.
