

**STANFORD TOWNSHIP
BOARD MINUTES
SEPTEMBER 2, 2025**

1. **Call to Order:** The Stanford Township meeting was called to order at 6:03 pm by Chairman Loren Daudt.
2. **Roll Call:** Present were Chairman Loren Daudt, Supervisors Wayne Anderson and Scott Johnson, Maintenance Supervisor Kevin Springer, Treasurer Brenda Springer and Clerk Barb Vogtlin.
3. **Adopt Agenda:** Motion by Wayne second Scott to adopt the September 2, 2025 Township Agenda. Loren approved the motion.
4. **Approve Minutes:** Motion by Scott second Wayne to approve the August 4, 2025 Township Minutes. Loren approved the motion.
5. **Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of August 1, 2025 \$567,141.16; Receipts \$2,575.76; Interest \$686.11; Disbursements \$124,615.68; ending balance as of August 31, 2025 \$445,787.35. Security Bank & Trust Savings Account \$8,802.62; Interest \$5.94; ending balance \$8,808.56. Escrow Fund MG & D Properties \$85,656.90; Isanti Sportsman Club \$4,000.00. Motion by Scott second Wayne to approve the Treasurer's Report. Loren approved the motion.
6. **Commissioner's Report:** None.
7. **Meeting Open to Public:** Bryan Lemke was present regarding the cartway. Wayne said he talked to Bob Ruppe the Township Attorney regarding a private easement. Adjoining landowners have to maintain it jointly. Bryan said Holly at the County said it has to be a Township Road. Wayne said no.  - d. **Dahlia Shores:** The Board members will be doing a road review on September 4, at 3:00 pm in Dahlia Shores.
