

**STANFORD TOWNSHIP
BOARD MINUTES
SEPTEMBER 6, 2022**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:01 pm by Supervisor Wayne Anderson.
2. **Roll Call:** Present were Supervisor's Wayne Anderson and Scott Johnson, Alternate Deputy Dean Krause filled in for Loren Daudt. Maintenance Supervisor Kevin Springer, Treasurer Brenda Springer and Clerk Barb Vogtlin.
3. **Adopt Agenda:** Motion by Scott second Dean to adopt the September 6, 2022 Township Agenda. Wayne approved the motion.
4. **Approve Minutes:** Motion by Scott to approve the August 1, 2022 Township Minutes. Wayne seconded and approved the motion.
5. **Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of August 1, 2022 \$503,489.85; Receipts \$1,531.74; Interest \$43.78; Disbursements \$51,107.49; ending balance as of August 31, 2022 \$453,957.88. Flagship Bank Savings Account \$18,507.41; Interest \$3.35; ending balance \$18,510.76; \$150,000.00 in CD's. Motion by Scott second Dean to approve the Treasurer's Report. Wayne approved the motion.
6. **Commissioner's Report:** County Commissioner Greg Anderson said there will be a Public Hearing on September 20, 2022 at 9:30 am at the Government Center regarding Townships with Planning Commissions or a Subdivision Ordinance to have input on final plats.
7. **Meeting Open to Public:** None.
8. **Items to be added:**
 - a. **Hakanson, Anderson Engineers:** Shane Nelson of Hakanson, Anderson would like to meet with the Town Board to go over the Road Ordinance. Township Attorney Bob Ruppe will also be present. Post on website regarding Preliminary Plans 6 to 8 weeks prior to meeting. Shane also questioned when a pond is put in a development, who maintains it. The Board has concerns with the Dahlia Shores development. There will be a Special Meeting September 27, 2022 at 2:30 pm at the Stanford Town Hall. Also, the Township Board will have a Planning Commission meeting on October 3, 2022 at 6:00 pm prior to the regular Board meeting.
 - b. **SWCD – Alum Treatment:** The Soil Water District would like to close the public access to use it to do the Alum treatment. Motion by Scott second Dean to approve the closing of the access on September 13, 14, & 15. Wayne approved the motion.
 - c. **Gravel:** Kevin stated that Spencer Brook will go half on gravel for 277th Avenue if we will go half. This is a shared road and Hass gravel will be used. Motion by Dean second Scott to approve our half of the road. Wayne approved the motion.

9. Miscellaneous: Richard Hansen of Bradford Township stated that East Central has money for funding projects if the Township had any projects they would like to apply for. There will be a Township Officer's Meeting on October 29, 2022 at 7:00 at the Government Center.
10. **Payment of Claims:** Motion by Scott second Dean to approve the claims. Wayne approved the motion.
11. **Adjournment:** Motion by Dean second Scott to adjourn the Township meeting at 7:53 pm. Wayne approved the motion.
