

**STANFORD TOWNSHIP  
BOARD MINUTES  
OCTOBER 2, 2023**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:00 pm by Chairman Scott Johnson.
2. **Roll Call:** Present were Chairman Scott Johnson, Supervisor's Loren Daudt and Wayne Anderson, Maintenance Supervisor Kevin Springer, Treasurer Brenda Springer and Clerk Barb Vogtlin.
3. **Adopt Agenda:** Motion by Wayne second Loren to adopt the October 2, 2023 Township Agenda. Scott approved the motion.
4. **Approve Minutes:** Motion by Loren second Wayne to approve the September 5, 2023 Township Minutes and the September 11, 2023 Special Meeting Minutes. Scott approved the motion.
5. **Treasurer's Report:** Brenda read the Treasurer's Report as follows: Beginning balance as of September 1, 2023 \$70,110.59; Receipts \$1,750.15; Interest 0.69; Void Check # 9873 for \$144.15; Disbursements \$51,668.47; ending balance as of September 30, 2023 \$20,346.11. Flagship Bank Savings Account \$18,649.69; Interest \$13.34; ending balance \$18,663.03; \$150,000.00 in CD's. Motion by Loren second Wayne to approve the Treasurer's Report. Scott approved the motion.

The County Board approved the internal promotion of Angie Larson to full time Auditor-Treasurer/Chief Financial Officer, effective October 5, 2023.
