BOARD MINUTES  
APRIL 3, 2017**

1. **Call to Order:** The Stanford Township meeting was call to order at 7:01 pm by Chairman Loren Daudt.
2. **Roll Call:** Present were Chairman Loren Daudt, Supervisors Wayne Anderson and Terry Burtson, Maintenance Supervisor Kevin Springer, Treasurer Brenda Smith and Clerk Barb Vogtlin.
3. **Oath of Office:** The Clerk Barb Vogtlin gave Supervisor Terry Burtson the Oath of Office.
4. **Adopt Agenda:** Motion by Wayne second Terry to adopt the April 3, 2017 Township Agenda. Loren approved the motion.
5. **Approve Minutes:** Motion by Wayne second Terry to approve the March 6, 2017 and the March 16, 2017 Township Minutes. Loren approved the motion.
6. **ISD #15 Superintendent - Troy Ferguson:** ISD #15 Superintendent Troy Ferguson explained the Bond that will be voted on May 23, 2017.
