

**STANFORD TOWNSHIP  
BOARD MINUTES  
SEPTEMBER 4, 2018**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:00 pm by Chairman Terry Burtson.
2. **Roll Call:** Present were Chairman Terry Burtson, Supervisor's Wayne Anderson and Loren Daudt, Treasurer Brenda Smith, Maintenance Supervisor Kevin Springer and Clerk Barb Vogtlin.
3. **Adopt Agenda:** Motion by Loren second Wayne to adopt the September 4, 2018 Township Agenda. Terry approved the motion.
4. **Approve Minutes:** Motion by Loren second Wayne to approve the August 6, 2018 Township Minutes. Terry approved the motion.
5. **Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of August 1, 2018 \$388,029.57; Receipts \$1,064.11; Interest \$275.95; Disbursements \$183,407.32; ending balance as of August 31, 2018 \$205,962.31. Flagship Bank Savings Account \$206,286.42; Interest \$148.92; ending balance \$206,435.34. Motion by Loren second Wayne to approve the Treasurer's Report. Terry approved the motion.
6. **Commissioner's Report:** None.
7. **Plat Approval – Golden Touch 2<sup>nd</sup> Addition:** Cheryl Pearson was present with a plat of changing a non buildable lot to a buildable lot. The Board didn't have any concerns regarding this request. Motion by Wayne second Loren to approve the plat for Golden Touch 2<sup>nd</sup> Addition. Terry approved the motion.
8. **Meeting Open to Public:** Deanna Bahr asked about gopher feet for Bob Collins. He has 200 pairs.

  - a. **Culverts on 253<sup>rd</sup> and Heilium Street:** The culverts have been installed and Kevin stated they look good and the water will now flow better.
  - b. **Blue Lake Pay:** The Township will give their donations to the Blue Lake and Long Lake Improvement Districts in October.
  - c. **Xenon Street:** Kevin stated the road is 22ft wide and said its to narrow to build the shoulders up. Loren said have Dennis Hall put shoulders in. Loren, Terry and Wayne will meet to look at the road.

Terry had complaints on 273<sup>rd</sup> & Long Lake Drive regarding pot holes and one where the asphalt is breaking apart. Also on Sullivan Woods Trail a sign is covered by a tree.
