

**STANFORD TOWNSHIP  
BOARD MINUTES  
APRIL 6, 2020**

**Re-Organization meeting:** This meeting was put on hold until the May 4, 2020 meeting.

1. **Call to Order:** The regular Township meeting was called to order at 7:05 pm by Supervisor Loren Daudt.
2. **Roll Call:** Present were Supervisor's Loren Daudt and Terry Burtson, Maintenance Supervisor Kevin Springer and Clerk Barb Vogtlin. Treasurer Brenda Springer and Chairman Wayne Anderson were excused.
3. **Adopt Agenda:** Motion by Terry to adopt the April 6, 2020 Township Agenda. Loren seconded and approved the motion.
4. **Approve Minutes:** Motion by Terry to approve the March 2, 2020 and the March 12, 2020 Minutes. Loren seconded and approved the motion.
5. **Treasurer's Report:** The Treasurer's Report was read as follows: Balance as of March 1, 2020 \$153,610.11; Receipts \$182.78; Interest \$80.26; Disbursements \$12,610.06. Ending balance as of March 31, 2020 \$141,263.09. Flagship Bank Savings Account \$108,050.52; Interest \$63.35; ending balance \$108,113.88; \$150,000.00 in CD's. Motion by Terry to approve the Treasurer's Report. Loren seconded and approved the motion.
6. **Commissioner's Report:** County Commissioner Greg Anderson stated that the County at this time is closed to the public. Some of the County employees are working from home. Also, there is COVID 19 information on their website. He stated that Richard Heilum from the County Hwy Dept., said that County Road 5 will be worked on again, and this year from County Road 28 to Hwy 47 will be resurfaced. He also stated that from Hwy 47 to County Road 10 will be reconstructed in 2022.
7. **Gravel Bids:** The Township received 2 gravel bids and they are as follows:

Hass Construction    \$11.90 per yard  
  
Motion by Terry to award the Gravel Bid to Hass Construction. Loren seconded and approved the motion.

- b. **Springers Place:** Motion by Terry to approve the Final Plat for Brandon Springer. Loren seconded and approved the motion.
- c. **269<sup>th</sup> Delineation:** Motion by Terry to go ahead with the delineation on 269<sup>th</sup> Avenue to get that road done. Loren seconded and approved the motion.
- d. **Crack Sealing:** Motion by Terry to go ahead with the crack sealing and also the painting of the white lines in our parking lot. Loren seconded and approved the motion.
- e. **Culvert at Blue Lake:** Kevin stated that Dennis Hall is too busy at this time to do the culvert at Blue Lake so he checked with Dirtworks and they can do it. The County does a lot of work with this Company. Motion by Terry to hire Dirtworks by the hour. Loren seconded and approved the motion.

**10. Clean Up Day:** Kevin stated that Chris Baumgardt said he would let him know in a week or two if he was going to do it. Chris said some other Townships have cancelled their cleanup day.

**11. Road Review:** This is postponed for the time being.
