

**STANFORD TOWNSHIP  
BOARD MINUTES  
MAY 4, 2020**

1. **Call to Order:** The regular Township meeting was called to order by Chairman Loren Daudt at 7:20 pm.
2. **Roll Call:** Present were Chairman Loren Daudt, Supervisor's Terry Burtson and Wayne Anderson, Treasurer Brenda Springer, Maintenance Supervisor Kevin Springer and Clerk Barb Vogtlin.
