

**STANFORD TOWNSHIP  
BOARD MINUTES  
MARCH 1, 2021**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:01 pm by Chairman Loren Daudt.
2. **Roll Call:** Present were Chairman Loren Daudt, Supervisor's Wayne Anderson and Terry Burtson, Maintenance Supervisor Kevin Springer, Treasurer Brenda Springer and Clerk Barb Vogtlin.
3. **Adopt Agenda:** Motion by Wayne second Terry to adopt the March 1, 2021 Township Agenda. Loren approved the motion.
4. **Approve Minutes:** Motion by Wayne second Terry to approve the February 1, 2021 Township Minutes. Loren approved the motion.
5. **Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of February 1, 2021 \$122,913.17; Receipts \$225.17, Void Ck # 9574 Traffic Marking Signal \$3,069.61; Interest \$4.08; Disbursements \$41,913.70; ending balance \$84,298.33. Flagship Savings Account \$108,446.24; Interest \$19.46; ending balance \$108,465.70; \$150,000.00 in CD's. Motion by Wayne second Terry to approve the Treasurer's Report. Loren approved the motion.
6. **Commissioner's Report:** None.
7. **Meeting open to Public:** None.
8. **Items to be added:**
  - a. **Sno-ghost Snowmobile Club:** The club had some concerns about 1 paragraph in the Contract. Loren said he will talk to Bob Ruppe. They also said that as long as they don't own the land 1 Supervisor has to sign the building permit.
  - b. **2<sup>nd</sup> Dwelling on Property:** Discussion was held regarding the 2<sup>nd</sup> dwelling on a property. Some people are in agreement with it but the lot size should make a big difference.
  - c. **Fire Station:** The Isanti Fire Department is buying the Police/Fire Station in Isanti. Wayne said the contract looks like the Police Department will own half of the building.
  - d. **Broad Ban:** Discussion was held regarding Broad Ban. It will be costly for Bradford, Stanford and Spencer Brook Townships. Wayne stated the company that got the bid probably won't be able to do it. He said he has been in contact with Century Link. Wayne said we should move forward, and we can always not commit if we need to. He said we will have to bond for it if we do. Motion by Wayne second Terry to proceed. Loren approved the motion. At the Annual meeting we can extend the meeting till November 1, 2021. Motion by Wayne

second Terry to add \$50,000 to the proposed budget and present it at the Annual Meeting. Loren approved the motion.
