

**STANFORD TOWNSHIP
BOARD MINUTES
APRIL 5, 2021**

1. **Call to Order:** The Stanford Township Meeting was called to order at 7:00 pm by Chairman Wayne Anderson.
2. **Roll Call:** Present were Chairman Wayne Anderson, Supervisor's Loren Daudt and Scott Johnson, Maintenance Supervisor Kevin Springer, Treasurer Brenda Springer, and Clerk Barb Vogtlin.
3. **Adopt Agenda:** Motion by Loren second Scott to adopt the April 5, 2021 Township Agenda. Wayne approved the motion.
4. **Approve Minutes:** Motion by Loren second Scott to approve the March 1, 15th, 23rd Township Minutes.
5. **Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of March 1, 2021 \$84,298.33; Receipts \$2,084.75; Void Check #'s 9007,9281,9539 and A/W totaling \$1,824.47; Interest \$3.48; Disbursements \$14,429.20; ending balance as of March 31, 2021 \$73,781.83. Flagship Bank Savings Account \$108,465.70; Interest \$14.86; ending balance \$108,480.56; \$150,000.00 in CD's. Motion by Loren second Scott to approve the Treasurer's Report. Wayne approved the motion.
6. **Commissioner's Report:** None.
7. **Gravel Bids:** The Township received 2 gravel bids as follows:

Hass Construction	\$11.90 per yard
- Motion by Scott second Loren to award the gravel bid to Hass Construction. Wayne approved the motion. Kevin stated the Crack Sealing is .02 cents higher than last year. Motion by Loren second Scott to approve the Crack Sealing in the amount of \$15,500.00 this year. Wayne approved the motion.
8. **Meeting Open to Public:** None.

 - a. **Blue Lake Dock:** The dock at Blue Lake needs repair. Loren will check at a place in Zimmerman but will also get a quote on a new 36-foot dock. Also the landing at blue lake, Wayne said we should check with the DNR about the landing and the dock.
 - b. **Fire Board:** Loren and Scott will go to the Fire Board meeting. The Isanti Fire Department bought the Station in Isanti, but the Police will also stay in the building.

- c. **Gopher Feet:** Gopher feet was \$2.00 per pair but now is \$2.50 a pair.
- d. **Rug Cleaning:** Loren will call and set up a time for the carpet to be cleaned at the Townhall. The cost is \$720.00.
- e. **Snowmobile Club:** Wayne stated that the Club is asking that if they are only here for 10 years, that the Township reimburse them for the whole value of the shed. Wayne stated is has been talking with Township Attorney Bob Ruppe regarding this issue.
- f. **Wages:** Starting next year Kevin will receive \$600 a month for Medical Insurance. He is asking for \$300 to start now and then up to \$600 after the first of the year. Motion by Loren second Scott to start paying the \$300 in May for Medical Insurance. Wayne approved the motion.
