

**STANFORD TOWNSHIP
BOARD MINUTES
JUNE 7, 2021**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:04 pm by Chairman Wayne Anderson.
2. **Roll Call:** Present were Chairman Wayne Anderson, Supervisor's Loren Daudt and Scott Johnson, Maintenance Supervisor Kevin Springer, Deputy Treasurer Wendy Daudt and Clerk Barb Vogtlin.
