

**STANFORD TOWNSHIP
BOARD MINUTES
NOVEMBER 1, 2021**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:01 pm by Chairman Wayne Anderson.
2. **Roll Call:** Present were Chairman Wayne Anderson, Supervisor's Loren Daudt and Scott Johnson, Treasurer Brenda Springer and Clerk Barb Vogtlin. Maintenance Supervisor Kevin Springer was excused.
3. **Adopt Agenda:** Motion by Scott second Loren to adopt the November 1, 2021 Township Agenda. Wayne approved the motion.
4. **Approve Minutes:** Motion by Loren second Scott to approve the October 4, 2021 Township Minutes. Wayne approved the motion.
5. **Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of October 1, 2021 \$224,248.28; Receipts \$4,793.66; Interest \$4.07; Disbursements \$84,210.06; ending balance as of October 31, 2021 \$144,835.95. Flagship Bank Savings Account \$18,498.89; Interest \$0.44; ending balance \$18,499.33; \$150,000.00 in CD's. Motion by Scott second Loren to approve the Treasurer's Report. Wayne approved the motion.
6. **Commissioner's Report:** County Commissioner Greg Anderson was not present, but it was stated that the Trucking Company on 261st Avenue, supposedly the owner is in jail according to the Isanti County Zoning Office. Also, the Zoning Office is trying to get them to get a CUP.
7. **Meeting Open to Public:** Mark and Paula Scheller, 2222 269th Avenue NW Isanti, would like to do a lot split on their property. The Board advised them to first go to Isanti County Zoning Department. Deanna Bahr, 2525 253rd Avenue NW, Isanti, would like to use the Townhall for Santa Claus Day on December 5, 2021. Motion by Loren second Scott to approve the use of the Townhall on December 5, 2021 at no charge because it is a community event. Wayne approved the motion. Don Davies, 27271 Blue Lake Drive, was present and spoke about the public access at Blue Lake. Wayne stated the public access is busy. Don said it will be busier now because the south side entrance on Blue Lake does not have any parking. Motion by Loren second Scott to approve the yearly donation to the Blue Lake Association of \$3,500.00. Wayne approved the motion.
8. **Items to be added:**
 - a. **Planning Commission - 2nd Dwelling:** The Isanti County Zoning Department will be having a meeting on November 10, 2021 regarding a 2nd dwelling on properties. Motion by Loren second Scott to approve any of the Board members to attend this meeting.
 - b. **East Side of Blue Lake:** At the October 4, 2021 meeting Jean Tuohy was present and asked about a road easement on Carr Street. She wanted to know if the Township could take over

the road. Don Davies stated that he was the one who put that road in and put in a cul-da-sac because Edling's owned the rest of the property on that side.

- c. **Road Recordings:** Wayne got copies of the road recordings.
- d. **Fire District:** Loren attended the Fire District Meeting. He said they are going for a 10% increase for Improvements. Loren said he made a motion for 7%.
- e. **Brush Cutting:** Kevin provided a map of the roads that he was doing the brush cutting on.

10. **Payment of Claims:** Motion by Loren second Scott to pay the claims. Wayne approved the motion.

11. **Adjournment:** Motion by Loren second Scott to adjourn the Township meeting at 7:36 pm. Wayne approved the motion.
