

**STANFORD TOWNSHIP  
BOARD MINUTES  
OCTOBER 3, 2022**

1. **Call to Order:** The Stanford Township meeting was called to order at 7:00 pm by Chairman Loren Daudt.
2. **Roll Call:** Present were Chairman Loren Daudt, Supervisor's Wayne Anderson and Scott Johnson, Maintenance Supervisor Kevin Springer, Treasurer Brenda Springer and Clerk Barb Vogtlin.
3. **Adopt Agenda:** Motion by Scott second Wayne to adopt the October 3, 2022 Township Agenda. Loren approved the motion.
