BOARD MINUTES
MARCH 3, 2025

- 1. Call to Order:** The Stanford Township meeting was called to order at 6:05 pm by Supervisor Loren Daudt.
- 2. Roll Call:** Present were Supervisor's Loren Daudt and Scott Johnson, Treasurer Brenda Springer, Maintenance Supervisor Kevin Springer and Clerk Barb Vogtlin. Chairman Wayne Anderson was excused.
- 3. Adopt Agenda:** Motion by Scott to adopt the March 3, 2025 Township Agenda. Loren seconded and approved the motion.
- 4. Approve Minutes:** Motion by Scott to approve the February 3rd and February 20th Township Minutes. Loren seconded and approved the motion.
- 5. Motion by Scott to approve the Treasurer's Report. Loren seconded and approved the motion.
- 6. Commissioner's Report:** County Commissioner Todd Christenson spoke about the Highway Users Tax Distribution Fund for local roads and bridges. He also talked about the poll tablets that the County may be getting. Also, Cannabis, there will be another meeting regarding the hours and events.
